

**BCF AUSTRALIA PTY LTD “CLUB BCF \$12,000 SHOPPING SPREE –

HOW TO ENTER

Members of Club BCF must purchase any product(s) from a participating BCF store nationally and present their Club BCF membership card at the time of purchase (so that their membership number can be recorded) during the promotional period to automatically receive one (1) entry into the next applicable monthly draw.

CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these Conditions of Entry. Participation in this promotion is deemed acceptance of these Conditions of Entry.
2. Entry is only open to Australian residents who are Club BCF members.
3. Employees and their immediate families of the Promoter, participating BCF stores and their agencies associated with this promotion are ineligible to enter.
