


80L SOLAR STORAGE BOX



Congratulations on your new XTM Solar Storage Box. Ensure that you have read this document in full prior to use. Failure to do so may result in incorrect operation and therefore impact on the product's performance and any warranty claim.

This guide covers the safe use of the solar photovoltaic module (the solar panel) that is attached to the lid of this storage box/cargo case. It does NOT cover the safe operation of any battery/device that you connect to this solar panel. Refer to the relevant battery/device instructions or contact the manufacturer of the battery/device.

SAFETY



- Cover the solar panel while handling components or connecting devices/batteries to ensure no electricity is being produced.
- The solar panel is not intended for use by children, and keep away from pets.
- Do NOT attempt to use the solar panels if the cables or plugs are damaged. These units do not contain serviceable parts. Ensure that any damage to the unit, cable or plugs are replaced by a qualified technician.
- Do NOT disassemble the solar panels. The warranty will be void if this instruction is ignored.
- Do NOT place the solar panels on fabric/leather/vinyl seats, directly on the battery or balanced in the engine bay of a vehicle.
- The solar panels may have sharp edges please handle with care.
- Do NOT bend or scratch solar panels.
- Do NOT walk, sit or place heavy items onto the solar panels.

GENERAL ADVICE FOR SAFE SOLAR CHARGING

This is general advice for safety precautions when charging batteries via the solar panel. Consult the battery manufacturer's instructions for specific safety requirements.

- The output of a single solar panel is suitable for 12V battery charging.
- Consider whether a solar controller/regulator is required for optimal charging.

- This cargo case forms an air- and water-tight seal when closed. Some batteries release explosive gases whilst charging, which could build up to dangerous levels inside the cargo case. Consult your battery manufacturer/instructions on the safe use of your battery.
- Only charge batteries that comply with the parameters of the solar panel.
- Always wear the appropriate personal protective equipment when working with/near batteries, as outlined by the battery manufacturer.
- Never smoke, use an open flame or create sparks near a battery or charger whilst charging as gases may cause an explosion.

CARING FOR YOUR SOLAR PANEL

- Build up of dirt and surface contaminants on the surface of the solar panel will affect performance.
- Use a clean microfiber cloth to clean solar panel surface.
- Do NOT use a high pressure hose to clean the solar panel.

SPECIFICATIONS FOR 80W (80L CARGO CASE) PANELS

- The specifications (below) of the solar panel is based on optimal laboratory conditions (testing conditions indicated below).
- Real world output may vary depending on the environmental conditions.
- The surface enclosure of the solar panel is dust-tight and watertight against light pressure water spray (IP65). The junction box, cable and Anderson plugs on the underside of the panel are not IP rated.

WARRANTY
